


<p><i>Application and removing instructions</i></p>	<p>The skin should be clean and greaseless for an ideal application. For base coating and large areas use a wet sponge, for fine lines and small decorations use the brush. Apply light colours first then darker colours. Colours are water soluble so small errors can easily be corrected using water. You can remove the painting with warm water and some soap.</p>
